TERMO ADITIVO Nº 001/2024 AO CONTRATO Nº 18/2024, entre a Prefeitura Municipal de Lavras do Sul e a empresa EDITORA FTD S/A.

A Prefeitura Municipal de Lavras do Sul, pessoa jurídica de Direito Público, inscrita no CNPJ sob nº 88.201.298.0001-49, neste ato representado pelo Senhor Prefeito Sávio Johnston Prestes, brasileiro, solteiro, servidor público municipal, portador da identidade nº 1034056307, CPF nº 487.828.580-04, residente e domiciliado em Lavras do Sul, doravante denominado CONTRATANTE, e de outro lado a empresa "EDITORA FTD S/A," CNPJ 61.186.490/0015-52, com sede em Porto Alegre - RS, na Rua Raimundo Barcelo, nº 344, Bairro Floresta, CEP 90.035-000, representada pelo Sr Uedli Moura Assis, CPF nº 016.183.225-32, doravante denominado CONTRATADO, resolvem firmar o presente contrato, de acordo com a Lei 14.133/21, mediante as seguintes cláusulas e condições:

CLÁUSULA PRIMEIRA

O objeto do presente termo aditivo é a SUPRESSÃO do valor contratual: Valor inicial atualizado do contrato R\$ 235.717,00 – R\$ 8.658,00 – R\$ 227.059,00 (-3,76%) do percentual este que advém da soma da redução atual dos seguintes itens:

ENSINO FUNDAMENTAL – ANOS INICIAIS:

*Anos iniciais (1º ano): 09 apostilas dos 4 módulos R\$ 481,00 – Valor anual por aluno – Totalizando o valor de R\$ 4.329,00

*Anos Iniciais (3º ano): 09 apostilas dos 4 módulos R\$ 481,00 valor anual por aluno – totalizando o valor de R\$ 4.329,00

ACRÉSCIMO do valor contratual: Valor inicial atualizado do Contrato R\$ 235.717,00 + R\$ 8.264,00 = 243.981,00 (+3,51%), sendo no momento solicitado o seguinte quantitativo para aquisição:

EDUCAÇÃO INFANTIL:

*Educação Infantil (4 anos): 12 apostilas dos 4 módulos R\$ 368,00 valor anual por aluno – totalizando o valor de R\$ 4.416,00

ENSINO FUNDAMENTAL – ANOS INICIAIS:

*Anos iniciais (4º anos): 8 apostilas dos 4 módulos R\$ 481,00 valor anual por aluno – 3.848,00

PORTANTO, a partir de agora o valor do contrato será de: R\$ 235.323,00

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Editora FTD S/A (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Getting paper copies

After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. Further, you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

All notices and disclosures will be sent to you electronically

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us. Thus, you can receive all the disclosures and notices electronically or in paper format through the paper mail delivery system. If you do not agree with this process, please let us know as described below. Please also see the paragraph immediately above that describes the consequences of your electing not to receive delivery of the notices and disclosures electronically from us.
